If a student is not picked up by 3:15 p.m. from school, he or she will be taken to the enrichment's program and parents will be asked to pay the enrichment expenses for the day. Registration Fee: \$35 per child/per year

Monthly Subscription: \$325 per student, due 5th each month. Collected through FACTS.

Drop-In Price: \$20 per day/student, if registered

Terms of Agreement:

1. We understand that a minimum \$10 late pick-up fee will be charged for each child if the child is picked up after 5:30 p.m. The fee will be charged automatically through FACTS. If the child has not been picked up by 6 p.m. and no attempt has been made by the parent/guardian to contact CSA, 911 will be called.
2. We understand that written notice of intent to exit the program must be given to CSA a minimum of two weeks in advance. If adequate notice is not given, we understand that two weeks of full payment will be billed to our account even though my child is not in attendance.
3. We the below signed person/parents have legal custody/legal guardianship of said minor, give permission for the said minor to attend any CSA program activities supervised by an authorized CSA staff member. Said minor is physically able and mentally prepared to participate in all activities.
4. We agree to pay the above stated fees by the fifth day of each month through FACTS.
